Emma and SLT have agreed that we have taken the lease on for 1 year and have given our 3 months' notice. This time next year the car park will be no more.  We are looking to recoup the cost. We have 42 spaces in total; we are looking to allocate parking for a year and charge staff if they want to use the car park.
